## Academic Quality Enhancement

Innovative teaching-learning methods, including problem-based learning, simulation-based training, e-content creation and blended learning approaches, were implemented to enhance student engagement and learning outcomes. A robust student assessment and evaluation system was implemented, comprising formative

assessments, internal assessments and practical assessments. A feedback mechanism was

established to gather valuable insights from students regarding teaching-learning processes,

infrastructure, and support services. Results analysis was done to identify areas for

improvement and implement targeted interventions.

**Infrastructure and Facilities** 

The IQAC played a crucial role in infrastructure development projects. Existing facilities like

the operation theatres were upgraded to state of the art Modular theatres which adhere to the

NABH standards for air conditioning requirements. The Skills lab was also updated with high

fidelity patient simulator mannequins which was greatly utilised for training of staff and

students. The smart board projectors in Lecture halls were updated to a full touch screen

digital whiteboard with internet access, audiovisual capabilities and note-taking features.

In order to make the hospital more accessible to persons of differing capabilities, a new

tactile pathway and printed Braille books with hospital information were made available.

At the same time, regular facility inspection rounds were held every 6 months for safety of

students, staff and patients. The in-house biomedical engineering team implemented a robust

preventive maintenance and calibration schedule to ensure the optimal functioning of all

equipment.

**Accreditation and Certification** 

The IQAC spearheaded the successful completion of the NABH accreditation process,

demonstrating the institution's commitment to quality and patient safety. NABL accreditation

was achieved for various laboratories, ensuring adherence to quality standards in laboratory

testing. ISO certifications were renewed for relevant departments, maintaining the
