ORDER :

The Director of Public Health and Preventive Medicine in his letter second read above has stated that the Dean, Tagore Medical College and Hospital, Rathinamangalam, Chennai has sought permission to have tie-up arrangements with the Primary Health Centers at Manampathy, Chengalpattu HUD and Primary Health Centre at Maduramangalam and Elichur in Kancheepuram HUD for their students to undergo Community level training. Hence, he has requested the Government to accord permission to Tagore Medical College and Hospital, Rathinamangalam, Chennai to utilize the Primary Health Centers at Manampathy, Chengalpattu HUD and Primary Health Centre at Maduramangalam and Elichur in Kancheepuram HUD for a period of 3 years from the academic year 2019 – 2020 to 2021 – 2022.

2. The Government, after careful examination, in the light of the recommendation of the Director of Public Health and Preventive Medicine decided to accept the same and grant permission to the Dean, Tagore Medical College and Hospital, Rathinamangalam, Chennai to have tie-up arrangements with the Primary Health Centers at Manampathy, Chengalpattu HUD and Primary Health Centre at Maduramangalam and Elichur in Kancheepuram HUD for a period of three years from the academic year 2019 – 2020 to 2021-2022 for availing field practice of their MBBS students, subject to the following conditions:-

Multipurpose Hall (1000 Sq.ft.) with Bathroom and toilet facilities and accommodation for CRRIs as per Medical Council of India Norms in the affiliated Primary Health Centers at Manampathy, Chengalpattu HUD; Maduramangalam and Elichur in Kancheepuram HUD should be constructed by the Medical College at their cost for training purpose within six months from the date of issue of Government order.
 - ii) the institution should pay the prescribed fees as per G.O. (D) No.1258, Health and Family Welfare Department, Dated: 20.11.2014 and updated from time to time, for imparting special training.
3. The Director of Public Health and Preventive Medicine is directed to take necessary action, accordingly.
