| Preamble | <p>The Expanded Program for Immunization (EPI) in India was launched in 1978. The ambit of EPI was increased with the inclusion of measles vaccine (and discontinuation of typhoid vaccine) in 1985 and it was renamed as the Universal Immunization Program (UIP).</p> <p>The aim of UIP was to cover all districts in the country by 1990, in a phased manner and target all infants with the primary immunization and all pregnant women with TT immunization. For almost 2 decades, UIP did not add any additional vaccine. However, since 2006, vaccines namely Hepatitis B, second dose of measles and Japanese Encephalitis (JE) vaccine have been introduced. During the same period, a number of other safe and efficacious vaccines have become available for major killers like pneumonia and diarrhea, which are being used in the immunization programs of many developing and developed countries.</p> |
